SEWARD MEMORIAL LIBRARY BOARD MEETING

Notice of this meeting was simultaneously given to all members of the Library Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

1. CALL TO ORDER & RECOGNITION OF OPEN MEETINGS ACT AVAILABILITY

The meeting was called to order at 4:35 p.m. by Chairman Juanita Hill, who highlighted the availability of the Open Meetings Act.

2. LIBRARIAN'S REPORT

A. <u>Programs</u>: The summer adult reading club was finished with a pizza party attended by nearly 50 participants and guests. An informal poll was taken and those present liked competing against each other better than competing against York, so staff will repeat this method next summer.

Fall programs are underway now. The Wednesday early morning, Thursday after school and Thursday night story times did not have enough registrations to take place. Staff is visiting Bright Beginnings daycare Wednesday morning instead. There remains three in-house story times happening, plus 6 after school clubs (2 on Fridays).

The Library sent out 195 Leading to Reading cards last month.

B. Staffing: Jessica Cox has been hired as a part time Library Clerk. Two interviews for the Library Assistant II position have been held and a decision will be made soon

Facility: The damage to the soffit over the drive-up window has been repaired. To date no one has been charged with committing the hit-and-run so the library budget is covering the insurance deductible of \$1,000.

C. Statistics: Circulation for last month is down 1,117 from the previous month and down 1,503 from last year. Circulation for the previous 12 months now totals 96,024, not including OverDrive use. The collection now stands at 54,161 items not counting OverDrive resources.

Attendance for last month is down 223 from the previous month and down 1,327 from last year.

Computer use was down 1 from last month and down 66 from last year.

3. CIRCULATION POLICY-review of non-resident definition and any action needed

Pfabe made a motion to add the word "dependent" in front of "child" in the definition of a family unit and to clarify that a non-resident family unit is the same. Lamberty seconded the motion.
